#### 2. PROGRAM

- 2.1 Name of Program Proposal: I'm Thumbody Special
- 2.2 Program (Mission) Statement: The mission of MHANWI is to transform our community through proven programs that educate, empower, and strengthen the way individuals and families function for life. MHANWI understands the best way to address bullying is to stop it before it starts. I'm Thumbody Special (ITS) helps raise awareness of bullying within the school community while promoting self-esteem and conflict resolution, Partnering with teachers and students to address bullying helps sustain prevention efforts over time.
- 2.3 Program Overview: Prevention research is clear and indicates the need for character education as a means of preventing child abuse, neglect, school violence and bullving. MHA National reports that one-third of U.S. students experience bullving, either as a target or a perpetrator (Journal of the American Medical Association); more than 70 percent of teachers and students have witnessed bullving in their schools (www.stopbullving.gov).

  I'm Thumbody Special is presented to 3rd grade students in classrooms in Northwest Indiana, encouraging children to see differences as valuable while promoting respect for self and others to reduce bullying.

Mental Health America of Northwest Indiana (MHANWI) is a non-profit organization dedicated to overall wellness through personal and family support while remaining committed to our core principle of advocating on behalf of those experiencing emotional challenges. We lead from a foundation built on **prevention** and **empowerment** of vulnerable adults and children through education, referral, and advocacy. As an affiliate of the national Mental Health America organization, we adopt the philosophy of #B4Stage4, which stresses the importance of preventing/addressing mental health issues and adverse experiences early in life.

Our mission is to transform our community through proven programs that educate, empower, and strengthen the way families and individuals function for life. We currently have 13 programs that serve the Northwest Indiana community (Lake and Porter County). Over 90% of these programs are offered at no cost to those who receive our services. We proudly serve some of the most vulnerable homes and populations in Northwest Indiana and are grateful to be able to do so through generous funding that ensures critical help for those most in need. Each of our programs falls into one or more of five main categories of support: Home Visitation, Infant and Maternal Health, School Programming, Adult Mental Health Support, and Workplace Mental Health. With a strong foundation in prevention and early intervention, MHANWI programs stress the importance of preventing or addressing mental health issues early in life for the best possible outcomes (#B4Stage4). Much like a physical health condition, we don't want to wait until Stage 4, when there is much less we can do to heal the illness. It is our goal to take action before or at the first sign of distress. This philosophy informs our programs that support children and families through evidence-based home visitation, such as Healthy Families, Parents as Teachers, and Empowering Teens as Parents; as well as through support groups such as Mothers & Babies. These programs seek to identify and help mitigate risk factors associated with Adverse Childhood Experiences (ACEs). These are potentially traumatic events that occur in childhood, including violence, abuse, and growing up in a family with mental health or substance use problems. Toxic stress from ACEs can change brain development and affect how the body responds to stress. ACEs

are linked to chronic health problems, mental illness, and substance misuse in adulthood.

MHANWI's commitment to children and families has resulted in making us the largest

home visiting parent education agency in Northwest Indiana.

Because the work we do so closely connects us with families and their young children, we feel strongly about our responsibility to support the State's efforts to **promote student** health and wellbeing. Our national affiliate encourages families to work with their local MHA affiliate to make sure that schools treat bullying as violence and help them develop programs to prevent bullying and promote safe school environments. *I'm Thumbody Special* is an excellent resource toward this end.



I'm Thumbody Special helps elementary school students develop life skills to make decisions, resolve conflicts, and cope with challenges. The program focuses on mental health, self-identity, feelings and emotions; talking to a trusted adult, seeing differences as valuable, and fostering respect for self and

others to reduce bullying. The thumbprint logo was chosen as it represents the uniqueness of each individual - just as no two thumbprints are alike, no two people are alike.

I'm Thumbody Special builds healthy self-concepts; instills feelings of self-worth, individuality and responsibility; develops an understanding of each person's unique skills and interests and the value of their differences, strengths and individuality; and enhances self-awareness. The interaction with the students includes a discussion on the positive value of difference and how to change negative thoughts to positive thoughts.

MHANWI has been facilitating *I'm Thumbody Special* in classroom settings for over 15 years and shifted quickly to develop a virtual option in 2020. Our Program Specialist works with teachers and students to demonstrate how to work together as a group, understand personal differences, resolve conflict, and handle peer pressure. By making it clear that in spite of differences, we are all alike in many ways, this program helps students accept and value differences among them, which leads to better impulse control and a reduction in conflicts. Building a strong sense of self-worth through *I'm Thumbody Special* empowers children to reject destructive behavior and embrace diversity and community.

Teacher feedback is important to the success of the program. In 2023, following a presentation to students in Cedar Lake, IN, teachers noted, "The students were engaged the whole time and enjoyed figuring out their thumbprints," "I know the 'Thumbprint' conversation will continue for days to come!" and "The kids received a good message while having a good time." Participating children also completed a survey, in which 95% of students agreed that they were satisfied with the program and would like to have another presentation for their class in the future. MHANWI served 1,178 students through I'm Thumbody Special in the 2023 calendar year. Unfortunately, due to funding cuts at the local level, MHA will only be able to serve a fraction of schools requesting this long standing program, unless new funding can be secured soon.

MHANWI has partnered with school systems throughout Lake County, including some of our more vulnerable communities, to bring the popular *I'm Thumbody Special* program to students. All public and private schools in Lake County are invited to participate by scheduling *I'm Thumbody Special* presentations for their 3rd grade classrooms. In the past two years, we've served the following school systems: Crown Point, East Chicago, Griffith, Hammond, Hanover Central, Highland, Merrillville, Tri-Town (Lake Central School System), and Whiting. Due to limited funding, not all schools that show an interest each year receive services; services are completed on a first come, first schedule basis as time and funding allows.

The recent global pandemic necessitated that organizations identify innovative and flexible strategies to engage participants. In addition to providing Thumbody Special programming face-to-face in the school setting, we are pleased to offer the flexibility of a virtual presentation if that better meets the needs of the school. At the preference of each district, MHANWI will continue to offer both virtual and in-person sessions to meet the needs of students and educators. MHANWI staff have developed *I'm Thumbody Special* program kits to distribute in the classroom, and coordinate with teachers to supplement with a fully interactive webinar.

To measure success and monitor results, MHANWI conducts post-program surveys among teachers and students to gauge student learning around self-confidence, self-esteem and how to get along better with others. Building a strong sense of self-worth through *I'm Thumbody Special*, enables children to reject destructive behavior and emerge as successful adults.

Increasingly, educators and mental health professionals are recognizing the critical role resiliency plays in a child's ability to achieve his or her social and academic potential.

## 2023 Year End Lake County-Wide Data for I'm Thumbody Special Programming

- 1,178 students educated on bullying prevention/mental health promotion
- 74 teachers provided resources for bullying prevention/mental health promotion
- 9 participating school systems
- 98% of students show an increase in knowledge of self-esteem.
- 99% of students believe the information gained from Thumbody will help their peer relationships.

<u>Timeline</u>: I'm Thumbody Special is an ongoing program at MHANWI, which will allow us to execute quickly, if funded. ITS is school-based; some activities are time bound based on school parameters and participation.

Wendy holds a Masters of Public Affairs and a Bachelor of Arts in Sociology from Indiana University Northwest and has over twenty years of experience administering child abuse prevention programs. Wendy is also endorsed as an Infant Mental Health Mentor, awarded by the Infant Mental Health Alliance. She is a National Trainer for Healthy Families America and is dedicated to strengthening and expanding parent education and family wellness services throughout the region. She has been active on numerous task forces, committees, and boards, including Prevent Child Abuse Lake County, Lake County Community Action Team,

and the statewide Child Abuse Prevention Framework Advisory Team. Wendy is a member of the MHANWI Management Team, reporting directly to VP of Operations, Kim Smith.

Vickie Rainwater, BA, IMH-E® (II), Program Specialist has 23 years of experience working with diverse populations. She manages our *Infant Safe Sleep*, Smoke Free Moms, and I'm Thumbody Special programs. Vickie is a trained Tobacco Treatment Specialist through the University of Massachusetts; a Certified Parent Educator / Supervisor; and is endorsed in Infant Mental Health and Adult Mental Health First Aid. She is a member of the Indiana Early Learning Advisory Council, Indiana Perinatal Quality Improvement Collaborative, Indiana Healthy Opportunities for People Everywhere (IHOPE) - Education Matters Committee, Lake County Community Tobacco Prevention & Cessation Coalition, Rethink Tobacco Indiana, and Community Advocates of Northern Indiana.

## A. School Health Liaison

## **Budget Narrative - I'm Thumbody Special - Bullying Prevention Programming:**

Personnel Salaries (includes Employee Tax): (\$12.068): Supports 6 hours per week (0.15 FTE) for Lead Facilitator Vickie Rainwater providing self-esteem and bullying prevention workshops to 3rd grade classrooms throughout Lake County. Also includes 1 hour per week for Director of Programs and Partnerships providing oversight and coordination of data analysis and reporting, and partnership building.

<u>Fringe: (\$1,978)</u> Cost of health, dental, vision, life, Short & Long term disability and retirement match benefits of program team, based on current premium as percentage of gross wage.

<u>Supplies: (\$7,468)</u> Includes the purchase of ink pads, thumbprint cards, magnifying glasses, pencils, stickers, printing workbooks and outcomes surveys for each 3rd grade student. Kit estimated at \$4 per student x 1,500= \$6,000. Also includes the purchase of a new laptop and monitor - \$1,200, and general office supplies = \$268.

<u>Travel: (\$735)</u> Mileage Reimbursement for staff travel onsite to schools for facilitation of session with 3rd grade classes, and to partnership meeting, calculated at 1,500 miles x 0.49/mile.

<u>Marketing/Outreach: (\$1,500)</u>: Purchase of promotional items, brochures, rack cards, business cards, for outreach to local school districts promoting anti-bullying and positive self-esteem messaging.

Other: Admin/Indirect (10%): Supports a portion of general administrative support dedicated to this project including finance, payroll, human resources, and IT support.

## 3.3 Proposed Schedule of Payments:

MHANWI would work with whatever the preferred schedule of payments is most convenient for the Lake County Department of Health. MHANWI has worked with upfront funded grants that require periodic spenddown reporting as well as reimbursement grants that require back-up of expenditures and invoices for costs already incurred against a contract total amount. Per board policy, MHANWI holds a small operating surplus of general funds in order to cover operational costs in the occurrence of delay of payment from a funding source to ensure program sustainability.

Ideally, quarterly or bi-annulal upfront payments with spenddown tracking would be ideal in order to more efficiently manage cash flow and implementation of planned activities without the potential cash flow delay of a reimbursement payout arrangement. Our internal controls for fiscal management of this grant will include monthly spenddown tracking regardless of the payment arrangement to ensure good fiscal stewardship. We will work within whatever guidelines and systems prescribed by the Lake County Department of Health for this funding.

#### 2.7 REPORTING FORMAT:

Evaluation has been integral to the success of MHANWI programming since its inception. MHANWI uses its considerable programmatic expertise with families and their children, as well as support from national, evidence-model organizations, to achieve measurable results. Data for this project will be collected at service intervention for each participant, through teacher report and will include gathering of demographic information including residence, race and ethnicity, and age. Participants receiving I'm Thumbody Special will also complete a feedback survey to capture overall satisfaction as well as reported intention of participants to implement learned strategies. Data is collected, correlated and presented by the I'm Thumbody Special Coordinator to the Program Director and VP of Operations for KPI impact tracking and performance outcomes analysis. Information is utilized to inform reporting to funders as well as program CQI (Continuous Quality Improvement) planning. Reporting on deliverables outlined in the table provided above in Section 2.6 will be provided to the Lake County Department Health First Indiana as per funder directive.
