☐ Interviews and negotiations with industrial or commercial prospects or agents of industrial or commercial prospects by the Indiana Economic Development Corporation, the Office of Tourism Development, the Indiana Finance Authority, the Ports of Indiana, an Economic Development Commission, the Indiana State Department of Agriculture, a local Economic Development Organization (as defined in IC 5-28-11-2(3)), or a governing body of a political subdivision. **IC 5-14-1.5-6.1(b)(4)**

☐ To receive information about and interview prospective employees. **IC 5-14-1.5-6.1(b)(5)**

☐ With respect to an individual over whom the governing body has jurisdiction, to receive information about the individual's alleged misconduct and to discuss, before a determination, the individual's status as an employee, a student, or an independent contractor who is a physician. **IC 5-14-1.5-6.1(b)(6)**

☐ To discuss a job performance evaluation of individual employees. This subdivision does not apply to a discussion of the salary, compensation, or benefits of employees during a budget process. **IC 5-14-1.5-6.1(b)(9)**

☐ When considering the appointment of a public official, to do the following:(a) develop a list of prospective appointees; (b) consider applications; (c) make one (1) initial exclusion of prospective appointees from further consideration. **IC 5-14-1.5-6.1(b)(10)**

☐ To train school board members with an outside consultant about the performance of the role of members of public officials. **IC 5-14-1.5-6.1(b)(11)**

☐ To prepare or score examinations used in issuing licenses, certificates, permits or registrations under I.C.15-5-1.1 of I.C. 25. **IC 5-14-1.5-6.1(b)(12)**

☐ To discuss information and intelligence intended to prevent, mitigate, or respond to the threat of terrorism. **IC 5-14-1.5.6.1(b)(13)**

☐ To train members of a boards of aviation commissioners appointed under IC 8-22-2 or members of an airport authority board appointed under IC 8-22-3 with an outside consultant about the performance of the role of the members as public officials. **IC 5-14-1.5-6.1(b)(14)**
