The School Corporation may issue bonds or enter into a lease for the renovation, improvement, construction of additions, equipping and general improvements at academic buildings of the school corporation, including but not limited to renovations and additions at Hammond Central High School and Morton High School, which is estimated to cost \$84,220,000 over twenty-five (25) years.
