The property tax increase requested in this referendum was originally approved by the voters in 2017 and if extended will increase the average property tax paid to the school corporation per year on a residence within the school corporation by 50.37% and if extended will increase the average property tax paid to the school corporation per year on a business property within the school corporation by 45.07%.

Shall the School City of Hammond increase property taxes paid to the School Corporation by homeowners and businesses? If this public question is approved by the voters, the average property tax paid to the School Corporation per year on a residence would increase by 35.76% and the average property tax paid to the School Corporation on a business property would increase by 32.45%. The School Corporation may issue bonds or enter into a lease for the renovation, improvement, construction of additions, equipping and general improvements at academic buildings of the school corporation, including but not limited to renovations and additions at Hammond Central High School and Morton High School, which is estimated to cost \$84,220,000 over twenty-five (25) years. 
